NOTICE of PROPOSED GRANT of a MINING LEASE ML 100351 – Dated 11 September 2023 – Ballymore Resources Limited

OBJECTION – excerpts from Form MRA-20 Version 8 – Submitted 14 December 2023

GROUNDS FOR OBJECTION;

That it is unreasonable and environmentally unsatisfactory that the Department of Environment and Science should approve an application to have existing Environmental Authority Permit - EPSL00460513 - Effective Date: 19-Nov-2010 amended to add MLA 100351.

It is unacceptable that an application to have an EA approval granted in 2010 extended to cover proposed mining project MLA 100351 for an additional fifteen years without requiring new impact assessments addressing threats to water quality, flora and fauna including endangered and threatened species, and environmental nuisance issues for the residents of the small village of Dittmer.

The Federal government Reef 2050 Water Quality Improvement Plan identifies the Proserpine Catchment area as draining to the Great Barrier Reef and targets have been set to consider land use and pollutant loads from the water catchment area.

The site is situated in the Proserpine Catchment area. The water from this area provides drinking water for Dittmer residents, drains to the Proserpine Dam which provides drinking water to residents of Whitsunday and irrigation for agriculture and finally drains to the waters of the Great Barrier Reef.

The site is also identified as within a Statewide Biodiversity Corridor, habitat for the Endangered Proserpine Rock Wallaby, Northern Quoll and Greater Glider along with endangered and vulnerable plant species, Koala habitat, MSES wildlife habitat, MSES regulated vegetation (essential habitat) and the Proserpine State Forest.

In addition, recent reports made to WCC appear to indicate the proponents may be breach of EPSL 00460513 which is a code compliant EA that requires the EA holder to comply with all conditions of the Eligibility Criteria for Mining Lease Projects. If this is the case, WCC has great concerns for the environmental protection of MLA 100351.

In the circumstances it is unconscionable that an application relying on an EA approval granted thirteen years ago be amended to include MLA 100351, which if granted has a term of fifteen years with the possibility of renewals for terms not exceeding fifteen years.

Until this matter has been addressed, Whitsunday Conservation Council object to the granting of MLA 100351 on the grounds that insufficient environmental protection is being applied to this project by either, or both, the State and Federal governments.
